Find High-Paying — Benefit Loaded — Government Jobs!

It turns out there are thousands of job vacancies advertised daily in the federal job market regardless of proposed federal downsizing initiatives. Many retirements are projected as each day for the next 19 years 10,000 baby boomers turn age 65! Hiring will be driven by these retirements along with the need to staff over 100 new agencies and regulatory organizations due to the healthcare and banking legislation passed in 2010.

Why are federal jobs so appealing? For starters, the average annual federal worker's compensation — pay plus benefits — is \$123,049 compared to just \$61,051 for the private sector. New hires for hard-to-fill positions may be eligible to receive student loan payoff assistance, relocation help and cash incentives. Uncle Sam's liberal benefit package far exceeds what the average private sector company offers including 13 days paid sick leave, up to 5 weeks vacation, 10 paid holidays, health insurance, and an exceptional retirement package with a fixed annuity.

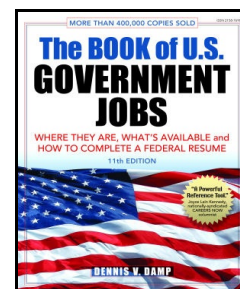
